Details on Submission and Review

JIOS is published twice annually, in spring and fall, online and print-on-demand. Submission deadline for the fall issue is 1 May each year and for the spring issue is 1 November of the previous year. JIOS publishes three types of articles:

- Research papers (8,000–10,000 words, including footnotes and references)
- **Insider's View** (3,000–7,000 words, including footnotes and references): contributions from practitioners illuminating the inner workings of international organizations
- Reviews of literature, disciplinary approaches or panels/workshops/conferences (single book reviews, panel or workshop reviews: 800–1,200 words, multiple book or subject reviews: 2,000–3,000 words, including footnotes and references)

Please send submissions to editors@journal-iostudies.org. For submissions and formatting guidelines, please see www.journal-iostudies.org/how-submit-your-paper. All papers will be reviewed by two or three external reviewers and then either accepted, rejected, or returned to the author(s) with the invitation to make minor corrections or revise and resubmit (medium to major changes). The final decision on acceptance of submissions rests solely with the editors.

John Mathiason is co-managing editor of JIOS and an adjunct professor at the Cornell Institute for Public Affairs, where he teaches graduate courses in international public and NGO management, evaluation of international programs and projects, and international human rights. Mathiason is also the managing director of Associates for International Management Services (AIMS). He was a career staff member of the UN Secretariat for over twenty-five years, having started with the UN as a technical assistance expert in the evaluation of social aspects of agrarian reform in Venezuela in 1966. Mathiason joined the UN Secretariat in 1971, working in rural and community development, program planning and coordination, and as deputy director of the Division for the Advancement of Women. He was the lead consultant for the mid-term review of the ten-year strategy of the UN Convention to Combat Desertification and a consultant on re-thinking social development for the UN Commission for Social Development and co-authored *Eliminating Weapons of Mass Destruction: Prospects for Effective International Verification*. Mathiason received a PhD in political science from the Massachusetts Institute of Technology.

Patrick J. Tiefenbacher is the executive director of Global Goals Consulting, a social business focusing on new development thinking based in Vienna, Austria. Previously, Tiefenbacher worked for the UN at country, regional, and headquarters level for almost two decades, most recently as chief of staff and principal advisor for development effectiveness in UNDP. He chaired several UN inter-agency mechanisms on strategic planning, country-level common services, and capacity development measurements, and led the secretariats of the Global Partnership for Effective Development Cooperation and the International Aid Transparency Initiative. Tiefenbacher received a master's degree in international affairs from Columbia University and a magister in political science and chemistry from Universität Wien.

Annett Richter currently works as a development cooperation specialist with the resident coordinator's office in Addis Ababa, Ethiopia. Richter conducts research on the UN reform "Delivering as One and UN System-Wide Coherence." From 2010 to 2013, she was a visiting scholar from Sciences Po in Paris at Columbia University in New York. Her professional experience includes UNESCO's Africa Department office and the executive office of UNESCO's Education Sector. Richter's expertise is sought out by international organizations, such as UNDP, and regional organizations, such as the UNDP Asia-Pacific Regional Centre in Bangkok, where she provided analytical support for the preparation of the 4th High-Level Forum on Aid effectiveness in Busan, Bangkok, in 2011, and the UNDP Regional Center for Africa in Addis Ababa for the 2nd Monitoring Round within the context of the implementation of the Global Partnership for Effective Development Cooperation (Kenya 2016). She has extensive diplomatic and academic training with the Diplomatic Academy of London/University of Westminster, Diplomatic Academy of the Russian Ministry of Foreign Affairs, and LSE-Peking University, and has received a master's degree in diplomatic studies and international relations and a BBA in management and business administration from L'Institut Supérieur de Gestion in Paris. Richter also holds active membership with the Academic Council on the UN System (ACUNS).

Luciana Campos is a researcher at the Center for Decision-Making Processes in International Politics and Foreign Policy (CEPDE). Campos also is a member of the Research Group of International Institutions at the Pontifical Catholic University of Minas Gerais, Brazil, where she is a PhD candidate in international relations, funded by the Foundation for Research Support of the State of Minas Gerais (FAPEMIG). Campos is currently a visiting doctoral candidate at Balsillie School of International Affairs in Canada. Her research interests include the

nexus of international politics, development cooperation, and public policy, with an emphasis on the research and teaching of institutional arrangements and reforms, focusing on decision-making processes and the operational dimension of international institutions and international organizations.
