**Dieter Kerwer** is a lecturer of international relations at the University of Munich. Kerwer's current research focuses on international organizations, international informal organizational arrangements, and the transnational regulation of global finance.

**Nils Brunsson** is a professor of management at Uppsala University and is affiliated with Score (Stockholm Centre for Organizational Research). Brunsson has published almost thirty books and numerous articles in the field of organization studies, including studies of decision-making, administrative reforms, and standardization. An expert on security and defense, political demography, and comparative federalism and multilevel governance, Leuprecht is regularly called as an expert witness to testify before committees of Parliament. His publications include nine books and scores of articles that have appeared in *Government Information Quarterly* (2016), *Armed Forces and Society* (2015), *Global Crime* (2015, 2013), the *Canadian Foreign Policy Journal* (2014, Maureen Molot Prize for Best Article), *Canadian Public Administration* (2014), the *Canadian Journal of Political Science* (2012, 2003), *Regional and Federal Studies* (2012), and *Terrorism and Political Violence* (2016, 2011).

French has written on the mindset theory of organizational leadership, applied to current nonprofit administration as well as ancient history.
